WHEREAS, on May 26, 2007, the Local Union convened a election committee meeting, in compliance with the terms of the previously issued and mailed May 11th notice; and







Re: Election of Local Officers and Delegates

1. In accordance with Title VII of the Labor Management Reporting and Disclosure Act of 1959, as amended and the Constitution and By-Laws of the AFGE Local 3599, the following offices shall be filled for a three year term during this election process:

President

Secretary

First Vice President

Treasurer

Second Vice President

Regional Steward

Delegate

2. The Election Committee shall adhere to the following schedule:

- Nomination notices to members: May 11, 2007
- Signed Statements of Nomination Acceptance: May 25, 2007
- Nominations to Nominating Committee: May 25, 2007
- Election Ballots To Members: June 1, 2007
- Elections Ballots to Committee: June 18, 2007
- Runoff Ballots to Members, if necessary: June 29, 2007.
- Runoff Ballots to Committee: July 18, 2007
- Installation: August 3, 2007 (or no later than 10 days after certification of the election results by the Election Committee if there is no runoff)

3. All members in good standing with the union are eligible to participate in the nomination and election process.

4. Nominations for candidacy to local office must be members of the AFGE for at least one year preceding nomination, be in good standing and MUST NOT be a member of any labor organization not affiliated with AFL-CIO.

5. A member may be nominated for more than one office. A member MAY NOT nominate more than one member for the same office.

6. The member making the nomination has the responsibility of informing the nominee of his or her nomination. The election committee will accept a written nomination accompanied by a signed statement of acceptance from the nominee, or a written

acceptance mailed separately from the accepting nominee, if the committee receives it by May 25, 2007.

7. Candidates shall not run for more than one office in the same election. However, the candidacy of DELEGATE shall not be considered to be covered by this provision.

8. Members will vote on the candidates for all offices. If a candidate runs unopposed, the candidate shall win the office by default. If a candidate for a particular office, except DELEGATE, receives MORE THAN 50% of the vote, there will be no runoff election to fill that office. If there are more than two candidates and none receive more than 50% of the vote, there shall be a runoff between the top two candidates.

9. The position of DELEGATE is determined by a plurality of the vote.

10. Nominations should be sent to AFGE Local 3599, P.O. Box 010086, Miami, Florida 33101 and must be RECEIVED BY MAY 25, 2007.

Election and Campaign Rules

1. Distribution of Campaign Literature

Local 3599 will honor any reasonable request by a candidate to distribute campaign literature to members at the candidate's expense. Requests will be honored in the order received. Campaign literature must be provided to the election committee in sealed, stamped envelopes which are ready for mailing. Each candidate should check with postal officials to determine the proper postage.

2. Campaign Restrictions

Federal law prohibits the use of any union or employer funds to promote the candidacy of any person in a union officer election. This prohibition applies to cash, facilities, equipment, vehicles, office supplies, email, etc., of AFGE Local 3599 and any other union, and of employers whether or not they employ Local 3599 members. Union officers and employees may not campaign on time paid for by the union or by the employer.

Candidates cannot use agency email or fax machines to campaign. Such use is a violation of federal law and cause for rerunning the election. In such a case, the election committee should inform the members in the notice of the rerun election the reason for its decision.

Federal law also provides that candidates must be treated equally regarding the opportunity to campaign, and that all members may support the candidates of their choice without being subject to penalty, discipline, or reprisal of any kind.

3. Voter Eligibility

Any member whose signed dues withholding form was accepted by a responsible officer of the local will be eligible to vote in this election.

4. Election Notice and Questions or Problems

A notice of election is being mailed to the last known home address of each Local 3599 member. Candidates and members with questions about the nomination or election procedures should contact a member of the election committee whose contact information appear on the notice and will also be posted on the Local's website www.afge3599.org.

5. Observers

Candidates are entitled to have observers present throughout the election procedure, including the tally of ballots. Observers must be members of Local 3599. Candidates should submit the names of their observers in writing to Election Chairpersons as soon as possible after their nominations. Candidates may serve as their own observers.

6. Election Results

The election results will be posted at the Local's website, www.afge3599.org after the tally is completed.


7. Protests


Appendix A, Part III of the AFGE National Constitution provides that any member may challenge a local union officer election by filing a protest in writing with the election committee prior to, during, or within 10 days after the election results are announced or posted.

The above rules are not all inclusive. Additional election rules or clarifications may be issued by the Local 3599 election committee as needed during the nomination and election period.
